- 6. The title for the tender from the BLM is closer to becoming a reality.
- 7. There was discussion on adding information regarding the Burn Permit requirement on the county WEB site and adding to the "Code of the West" pamphlet that is handed out to anyone looking at property in our district.
- 8. Shem Bellah has been put on a leave of absence while he is working for Denver Fire.
