Fire Chief Report

- 1. Training: We were able to take the Wildland Refresher online with both stations taking part to stay below the mandated attendance levels at each site.
- Maintenance: We are developing a maintenance system with report sheet for any work on the equipment. Foam was added to 6311, and pumps were started and run.
- 3. We cleaned up several items in the station to clear floor space in the station.
- We received two, Gage Vecellio and Anthony Borja, we are reviewing them and checking references.
 - a. * MSA: to approve the start of the process with the two applications.
- 5. There was discussion regarding the process of after hiring an individual that we reevaluate the applicant after their probation period.

EMT Director's Report:

- 2. CDPHE grant The ambulance is coming along great; the installation of the black box and the power-load system is scheduled to be completed in the next 2 weeks. The ambulance should be delivered the first week of June.
 - a. I am working on a grant with "Brothers helping Brothers" to get updated bunker gear.
 - b. I am working with Lexipol to get a Homeland Security grant to upgrade/replace our radios.
- 3. RETAC There was no RETAC in the month of April
- 4. Training Covered the Guideline updates for our scope of practice.
- 5. Maintenance Installed an after market high idle on Rescue 2 to speed the idle of the unit up while on scene to help maintain the vehicle batteries.
